



**EASING OF RESTRICTIONS FOLLOWING COVID-19  
BRUNEI DARUSSALAM**

**ARCADES AND INDOOR PLAYGROUND**

**OPERATIONAL READINESS LEVEL 1**

**(From 27 July 2020)**

Specific Requirements for Arcades:

1. Arcades are allowed to operate at limited capacity of 30% from the usual capacity at any one time.
2. Only limited to **1 hour maximum for one person in one day**.
3. Arcades must be closed **for 30 minutes every 2 hours** for cleaning and disinfecting.
4. Carry out cleaning and disinfection of arcade consoles before and after operational hours. Prioritise frequently touched surfaces such as joystick, buttons and keyboard as well as movable objects such as netballs. Objects that cannot be washed, cleaned or disinfected **MUST NOT** be used.
5. Ensure a distance of at least 1 meter between games or consoles.

### Specific Requirements for Indoor Playground:

1. Indoor playgrounds are allowed to operate at limited capacity of 30% from the usual capacity at any one time.
2. Only limited to **1 hour maximum for one person in one day.**
3. Indoor playgrounds must be closed **for 30 minutes every 2 hours** for cleaning and disinfecting.
4. Carry out cleaning and disinfection of indoor playground before and after operational hours. Objects such as stuffed toys, toys resembling food items, toys that can easily be put in the mouth and in direct contact with saliva such as small plastic balls and toys that cannot be washed, cleaned or disinfected **MUST NOT** be used.

### General Requirements:

1. The management of arcades and indoor playgrounds are required to obtain BruHealth QR code specific for their premise and print out the QR code and place it at the entrance so that it can be scanned by visitors before entering and upon leaving the premise. This requirement is exempted for arcades or indoor playground in a restaurant that already has its own BruHealth QR code.
2. The management of arcades and indoor playgrounds are required to ensure cleanliness and physical distancing measures are practiced in accordance to the following instructions:
  - 2.1 Conduct temperature checks for all visitors at all entrances to the premise.

- 2.2 Provide hand washing facility or hand sanitizers for visitors' use.
  - 2.3 Encourage visitors and staff to wear face masks. Cloth face masks may be worn provided that it is washed daily after use.
  - 2.4 Frequently clean and sanitize the area, especially frequently touched surfaces such as tables, chairs, countertops, handrails and door handles.
  - 2.5 Clean game consoles and toys by wiping with soapy water and rinse with clean water. When dry, disinfect surfaces by wiping it with a piece of cloth that has been soaked in bleaching agents (such as Clorox®) which has been diluted, 1 part bleaching agent in 49 parts water, leave it to dry or rinse with clean water. Disinfection may also be done by wiping surfaces with alcohol (70%) impregnated wipe and leave to dry.
3. Visitors or staff who are showing symptoms of the infection or those with red BruHealth code are advised not to be at the arcade or indoor playground until they have recovered.
  4. Failure to comply with the instructions given is an offence under the Infectious Diseases Act (Chapter 204) and if found guilty, may be fined to up to \$10,000 or imprisonment for up to 6 months or both.
