# Message from the Minister of Health

Excerpt from The Honourable Pehin Orang Kaya Johan Pahlawan Dato Seri Setia Awang Haii Adanan bin Begawan Pehin Siraja Khatib Dato Seri Setia Awang Haji Mohd Yusof, Minister of Health speech during Muzakarah with Ministry of Health's specialists, doctors and dentists, which was held on the 13<sup>th</sup> July 2010.

"One of the immediate agenda is ensuring the implementation of the e-health project which is now rebranded as Brunei Darussalam Healthcare Information Management Systems (Bru-HIMS). The objective is to develop health databases and information system that support operational, professional and managerial functions of medical care and primary healthcare services. This will be achieved by the introduction of integrated Healthcare Information System that integrates relevant disciplines in medical and primary healthcare such as medical team, laboratory, radiology and pharmacy. Every episode of medical investigations and treatment from any treatment centers will be consolidated into one patient's Electronic Patient Record (EPR). Ultimately, one patient will virtually hold only one EPR which provides clinicians with continuous medical history of the patient. To assure successful implementation, the Ministry has established Bru-HIMS Steering Committee to steer and monitor the implementation of the project. Eight Bru-HIMS Technical Committees have also been set up to look into specific requirements for the application systems and members representing doctors and dentists group have been included. Strong team effort, high commitment and dedication of everybody involved in this project can bring the project to its successful completion."
