



MEDIA STATEMENT
ON THE CURRENT SITUATION OF COVID-19
IN BRUNEI DARUSSALAM

8 Rabiulakhir 1442 / 24 November 2020

1. The Ministry of Health would like to announce that today, Tuesday, 8 Rabiulakhir 1442 / 24 November 2020, **there is 1 new case** of COVID-19 infection in the country. Therefore, as of now the total number of COVID-19 cases in Brunei Darussalam is **150 cases**.
 - Case 150 is a man aged 37 years old who arrived in Brunei Darussalam on Royal Brunei BI874 flight on 13 November 2020 via Kuala Lumpur from Egypt. He showed no signs of infection and is currently being treated at the National Isolation Centre. The contact tracing at present has identified a total of five (5) contacts of which all of them have undergone the COVID-19 swab test and were confirmed negative for COVID-19.

2. With the detection of this latest case, there are two active case being treated at the National Isolation Centre. Meanwhile, of the total COVID-19 cases in Brunei Darussalam, a total of **145 cases** have been confirmed recovered.
3. At present, there are 9 import cases have been confirmed since the last local infection case was reported on 6 May 2020. At present, Brunei Darussalam has recorded 202 days without COVID-19 local infection case.
4. Today, a total of **558 individuals** are undergoing mandatory self-isolation at the monitoring centers provided by the Government, which are individuals that have just arrived in this country after traveling from abroad. At present, a total of **8,287 individuals** have completed their mandatory self-isolation at the monitoring centers.
5. In the past 24 hours, a total of **284 samples** have been tested for the SARS-CoV-2 virus that brings the total number of laboratory tests conducted since January 2020 to **75,916 tests**.

6. The Ministry of Health would like to remind the public to practice their social responsibilities by maintaining personal hygiene, practice proper cough and sneeze etiquette, recommended to wear a face mask in crowded public places and if feeling unwell, not to go to public places and attend social gatherings.

7. The public are still required to comply with all regulations and directives related to the reduction of social distancing measures that have been issued and are still in force at the moment such as to use the BruHealth application and scan the QR Code when they enter and exit premises, especially at public areas such as shopping malls, retail shops, restaurants, beauty establishments, barber shops and others. Premise owners are required to print and display their QR code at their respective entrances. The public are urged to take the usage of the BruHealth application seriously, especially in scanning the QR Code as it is used by the Ministry of Health for contact tracing purposes in the event of an outbreak of infection.

8. Any individual found to be in violation of or disobey any order issued shall be an offense under the Infectious Diseases Act (Section 204), which if found guilty can be issued compound fine up to \$5,000 or can be prosecuted in court carrying a fine up to \$10,000 or imprisonment up to 6 months or both. The Ministry will not hesitate to take legal action against anyone who does not comply with the directives issued.
9. The Ministry of Health will continue to monitor the situation of the outbreak at the national as well as regional and global level and carry out ongoing risk assessments to consider further mitigation measures.
